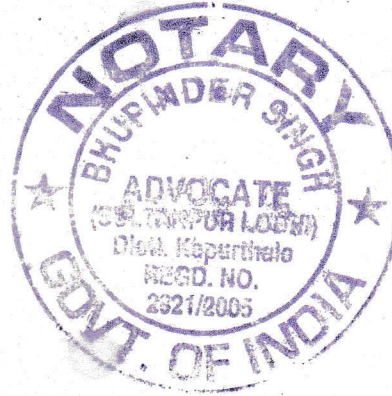

In respect of above subject considering deeply all the documents including affidavit, forwarded by the School management and recommendations by District Education Officer (Sen. Sec.) Kapurthala and Director Education Department (Sen. Sec.) Punjab, Chandigarh, the required N.O.C. is issued under the below noted conditions:

1. In future during inspection or on any complaint if it is found that N.O.C. has been applied giving wrong information or instructions issued by the government from time to time are not properly followed or the written conditions contained in the affidavit are not abide by, then in such circumstances at any time this N.O.C. can be recalled.
2. Teaching of Punjabi Subject will be compulsory in your school upto 10th Std., and CBSE New Delhi will ensure conditions of examination of Punjabi in such schools and it is emphasized that if

these conditions are not followed then NOC will be immediately recalled.

3. That School Management will strictly follow the notifications issued by Education Department Punjab under RTE Act, 2009 and rules framed under RTE Act 2009 for Punjab state.
4. After obtaining affiliation from CBSE New Delhi the school management will be bound to pay salaries and allowances etc. through account payee cheque to the teaching and non-teaching staff on the pattern of Government employees. If in case these conditions are not followed, the NOC issued will be recalled.
5. You and your management will ensure to provide any information demanded by District Education Officer of your district or by any Senior Officer of Education Department and will extend all required co-operation.
